

Fraternal Greetings!

The month of September was a busy period for SWL 283 in implementing its many plans. First, the investment committee review met our lodge investments led by our WB Jake Borillo, upon which the group decided to keep our original investments with Morgan Stanleywho gives the lodge steady income to pay the bills. The only thing that the committee needs to improve is to look for another investment for the life member's fund which has very little options.

Hopefully during our next meeting that the group will agree upon for a new investment plan.

Secondly, the solar panel installation was prioritized as our lodge averaged paying about \$600 to \$700 every month for the electric bill. With the solar panel our electric bill will surely be cut down as the lease will be steady every month during the 25 years- which is only our option. Business establishments like our building are not in a position to take advantage of the federal/county/ city tax rebates. We will require three different solar panel offers and so far we already got 2 estimates.

Thirdly, our Annual Golf Fundraising is fast approaching to be held in November and the Fundraising Committee, headed by WB Godfrey Catbagan, are just ironing out all that is needed to make it successful. But we still need each members to actively seek out for possible sponsors and players so we can raise more money for the multiple lodge projects we have in plan.

Aside from lodge plans we are still active in the progression of our line of officers for the upcoming year. So far we have qualified the Senior Warden and Senior Deacon positions this month and all we need now is the Junior Warden to get qualified. We will continuously strive to be the first lodge in our district to fill our officers lineup for the ensuing year.

We are delighted to witness our officers performing in other capacity not only in our lodge but at other lodges as well. The performance our officers exemplified were great even if it was their first time to perform such capacity. From the Stewards to the Deacons our officers did not falter in showing their best. It is remarkable of our claim as "the best lodge in the south; best lodge in the west: Soutwest Lodge.

A "Lewis" in speculative masonic language is a term given to the son of a mason. In ancient stone masonry, a Lewis is an iron that is forced into a cavity of a stone and used as a tool to lift the stone to lighten the load and laid the stone in place and made part of an edifice. Taken in this context, a Lewis is a symbol of strength. In freemasonry, the Lewis pin given to a freemason's son by his father symbolizes the raising of the son into position to take his place as part of the structure of freemasonry, "to bear the heavy burden of his aged parents, so as to render the close of their days happy and comfortable."

On September 8th, SWL did another 3rd Degree conferral and raised Bro. Dylan Gerstein who likewise received an exceptional degree conferral. One that was made very special by the past masters who proficiently exemplified the ceremony most specially and worthy of mention were the very realistic and artistic rendition by the 3 ruffians performed by: WBros. SUBJECT: Guidance for the Use of Face Coverings - Effective June 15, 2021

Guidance for the Use of Face Coverings

Note: This guidance takes effect on June 15, 2021 and will supersede all prior face coverings guidance. Background: The COVID-19 vaccines are effective in preventing infection, disease, and spread. Unvaccinated persons are more likely to get infected and spread the virus which is transmitted through the air and concentrates indoors. About 15% of our population remains without the option for vaccination (children under 12 years old are not yet eligible) and risk for COVID-19 exposure and infection will remain until we reach full community immunity. The purpose of this guidance is to align with CDC recommendations and provide information about higher risk settings where masks are required or recommended to prevent transmission to persons with higher risk of infection (e.g., unvaccinated or immunocompromised persons), to persons with prolonged, cumulative exposures (e.g., workers), or to persons whose vaccination status is unknown. When people who are not fully vaccinated wear a mask correctly, they protect others as well as themselves. Consistent and correct mask use by people who are not fully vaccinated is especially important indoors. In workplaces, employers are subject to the Cal/OSHA COVID-19 Emergency Temporary Standards (ETS) or in some workplaces the CalOSHA Aerosol Transmissible Diseases Standard, and should consult those regulations for additional applicable requirements.

Guidance for Individuals

Masks are **not required for fully vaccinated individuals, except** in the following settings where masks are required for everyone, regardless of vaccination status:

- On public transit[1] (examples: airplanes, ships, ferries, trains, subways, buses, taxis, and rideshares) and in transportation hubs (examples: airport, bus terminal, marina, train station, seaport or other port, subway station, or any other area that provides transportation)
- Indoors in K-12 schools[2], childcare[3] and other youth settings.
 - Note: This may change as updated K-12 schools guidance is forthcoming, pending updates for K-12 operational guidance from the CDC.
- Healthcare settings[4] (including long term care facilities[5])
- State and local correctional facilities and detention centers[6]
- Homeless shelters[7], emergency shelters[8] and cooling centers[9]

Additionally, masks are **required**** **for unvaccinated individuals** in indoor public settings and businesses (examples: retail, restaurants, theaters, family entertainment centers, meetings, state and local government offices serving the public).

For additional information, individuals should refer to CDC Recommendations for Safer Activities (see CDPH Masking Guidance Frequently Asked Questions for more information).

**Guidance for Businesses, Venue Operators or Hosts

In settings where masks are required only for unvaccinated individuals, businesses, venue operators or hosts may choose to:

- Provide information to all patrons, guests and attendees regarding vaccination requirements and allow vaccinated individuals to self-attest that they are in compliance prior to entry.
- Implement vaccine verification to determine whether individuals are required to wear a mask. Require all patrons to wear masks.

No person can be prevented from wearing a mask as a condition of participation in an activity or entry into a business.

Exemptions to masks requirements

The following **individuals** are exempt from wearing masks at all times:

- Persons younger than two years old. Very young children must not wear a mask because of the risk of suffocation
- Persons with a medical condition, mental health condition, or disability that prevents wearing a
 mask. This includes persons with a medical condition for whom wearing a mask could
 obstruct breathing or who are unconscious, incapacitated, or otherwise unable to remove a
 mask without assistance.
- Persons who are hearing impaired, or communicating with a person who is hearing impaired, where the ability to see the mouth is essential for communication.
- Persons for whom wearing a mask would create a risk to the person related to their work, as determined by local, state, or federal regulators or workplace safety guidelines.
